#### V. FY 2022-2023 Budget Discussion:

- a. Spreadsheet shown of 911 Workorders made (address markers, street name signs).
- b. January of 2016, fund balance was \$400k. November of 2021 fund balance just North of \$1.2M.
- c. Revenue is staying consistent, a bit. Spike in May 2017 was a grant year where we ended up with 2 \$100k grants.
- d. Expenses spiked the same year (2017), grant money in, grant money out. Still paying some of the trunk charges to Century Link and Windstream. Working on getting them nullified. 8:36
- e. Wage raises- 3% across the board with Emily, Randy, and Jeff. Asking for 1.5% and 1.5% totaling 3% for incentives. No certain methodology was used in the configuration of these numbers other then it's within proximity to other departments.
- f. The legislatures receive a report by January 1 by our PSAPS that outline their expenses. Legislatures are making comments about the amount of Fund balances sitting in local funds. Have added \$300,000 to the budget for next year for whatever you decide to spend it on. Roughly \$1.2 mil in Fund Balance.

#### VI. Address Marker Fee Structure Proposal

### VII. Chapter 24 Updates

- a. Some Cities have annexed some areas of un-incorporated Marion County. A City will annex an area and choose to retain the road name in the un-incorporated area, then choose a numerical address based on the Cities addressing grid. Trying to combine some Rural locations with City.
- b. Chapter 24 is the addressing ordinance for Marion County in the Marion County code of ordinances.
- c. 911 Board will need to make a recommendation to the BOS to pass that into law.
- d. Have been working on a draft to add to the existing ordinance that states "when a city annexes an area of un-incorporated Marion County. The city shall issue a new road name that is consistent with the city grid, and the city shall issue or assign a numerical address to residents in the affected area that are consistent with the city grid."
- e. When a draft is available, it will be sent out via email.
- f. Looking over Chapter 24 closely, if any other concerns arise, they will be noted in the email.
  - -No action needed at this time

#### VIII. Fund balance discussion/action on project(s)

- a. Discussion to buy radios
- b. Sheriff Sandholdt would like to get the radios in hands of different users to be able to use the different talk groups.
- c. Raymie suggests going forward with a testing proposal to see if it works.
- d. Pella Police Dept. is looking into a radio solution with infrastructure as well.
- e. Chief McSheehy would like to table the item for future.
- f. Chief Watson stated he's unsure why this is still a discussion, these radios are tested everyday so why are we waiting to order more 7-800.
- g. Fisher states it's not a matter of need, it's a matter of funding.

  - -Discussion Chief McSheehy asks about how much we believe the 911 board needs to retain due to a cost sharing conversation to be had soon with Pella Pd. Jeff believes at minimum \$400k.
