IV. 911 GIS Discussion

Discussion: IHSEMD and Geo-Comm contract to compile NG911 GIS data from all 99 counties. Zetron contracts with the State of Iowa to provide hardware and technology solutions that make up the Iowa Shared Services System. GeoConex integrator of Public Safety and Homeland Security systems. Marion County has never missed a GIS 911 payout in the history of the grant program \$24,000 (12k per PSAP) a year now \$3000 a quarter per PSAP. A letter sent from Blake DeRouchey, 911 Program Manager with Iowa Homeland Security and Emergency Management was shared advising that nearly two years ago it was brought to there attention that there were map discrepancies and Blake had assumed the project was complete as of now and the automatic push had been established to update PSAP maps. After being made aware of the process not being completed, Blake started pressing vendor partners for a resolution and indicating the delays in the project were not acceptable. The update is now automatically completed each week on a designated day. Needs to be periodic checks done to reassure the problem isn't persisting. Discussion: All dept's will have the opportunity to speak on their applications, some applications were turned in past the agenda deadline time and will not be able to speak or act on those items. Frustrations were voiced about not having all applications in prior to the meeting. When will decisions be made? Everyone has been talking about the importance of needing/wanting radios, why weren't we ready tonight. What is the total request of tonight's ask, is it more then what we have in the acct? If so this is a different story, and we need to readjust. Are we able to get buying power by purchasing multiple radios through specific vendors? Current fund balance is \$1.3m. \$900k has been set aside in the budget for these projects leaving \$400k in the reserve. Radios should be a top priority and budgeting needs to be from a small to big priority especially with the departments that don't have the funds to do so on their own. Total request of monies is \$1.5m. Total request of money for only radios Is \$852,011 (All radios including late applications). Wyman asks if members could meet with Motorola and Racom as separate group to see if we can get buying power. The 20-test radios can be passed out to help a department also once testing is complete. Wyman feels we need to keep 10 around in the event extra radios are needed for special events i.e.. Nationals etc. Next meeting will need to include the consolidated bids, other departments including a bit more information including maintenance in their application, and possibly do a maintenance agreement on old radio's. Radio projects must be turned in by the next meeting on April 26th at 6pm. These requests are based off no cost share by the requesting agencies if you can, make note for the next meeting.
