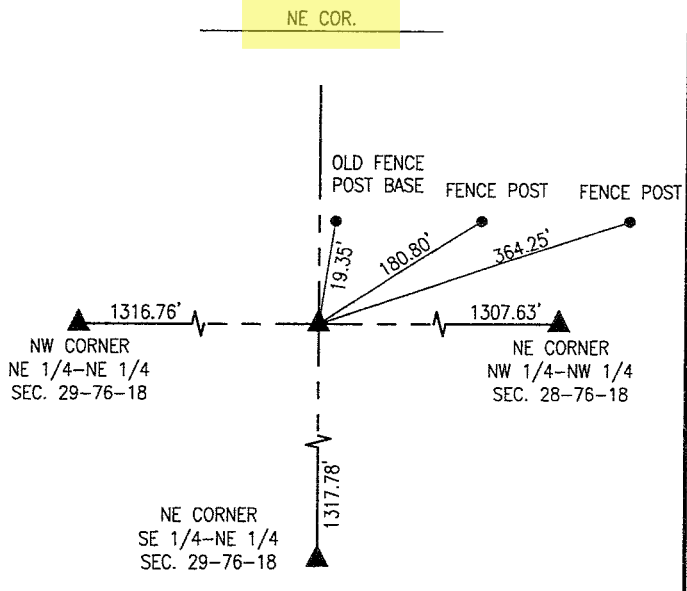
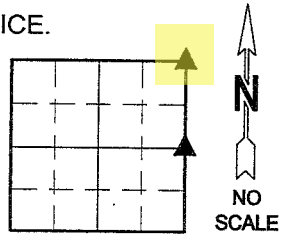

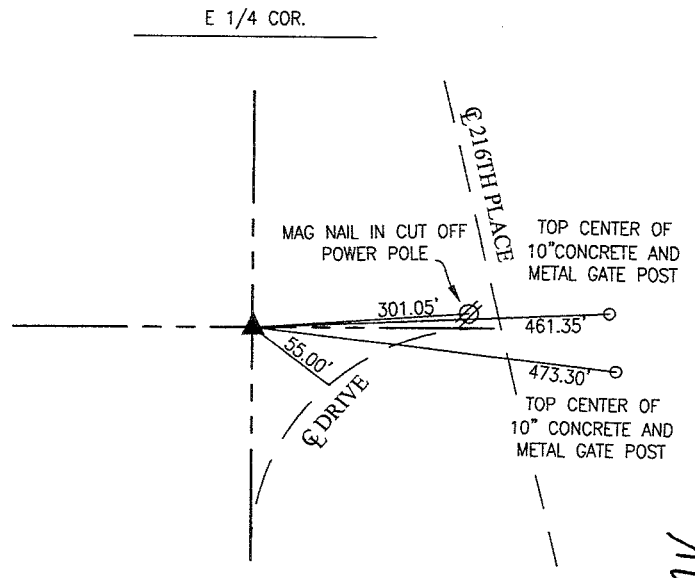


JULY 1969-PLS 6708

SEPTEMBER 2005-PLS 6708
 FOUND 1" PIPE OVER WPA CM 3.5' DEEP.

NOVEMBER 2023-PLS 14416
 1" PIPE HAS BEEN DOZED OUT.
 FOUND LIMESTONE ABOVE CM 24" DEEP AT
 EDGE OF FIELD AND DIKE. SET 5/8"x30"
 REBAR ON THE NORTH SIDE OF LIMESTONE.

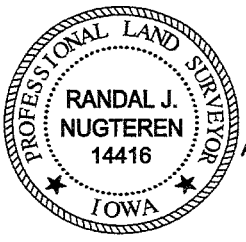


DECEMBER 1969-PLS 6708

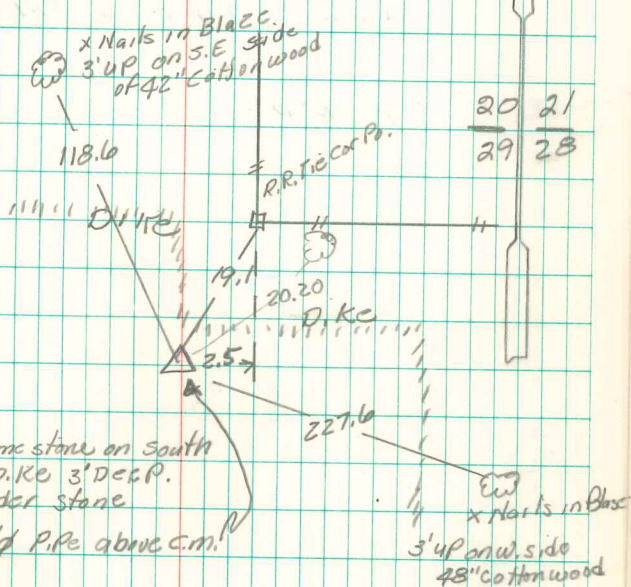
